Presented by Barb Petty. Barb is a CCSC instructor who has been training and competing in dog events for over 20 years, and has been an agility instructor for over 14 years. Her addiction for the canine sports started with the training and showing of a beagle in obedience in the 1970's. More recently, in addition to competing in obedience and herding, her dogs have earned top titles in various agility venues including 5 MACH titles, ADCH, as well as several Champion, Bronze, and Silver titles in the USDAA games of Gamblers, Snookers, Jumpers, and Relay. Her dogs are frequent qualifiers for AKC and USDAA National events, and her first agility dog, MACH2 Snickers, finished 7th in the 24" height division in 2001.

This workshop is for young dogs or puppies up to 12 months of age. This workshop will help you and your young dogs to build a relationship as a basis for your future agility training. Topics will include relationship exercises, focus, impulse control tools, and groundwork for developing future handling skills.
