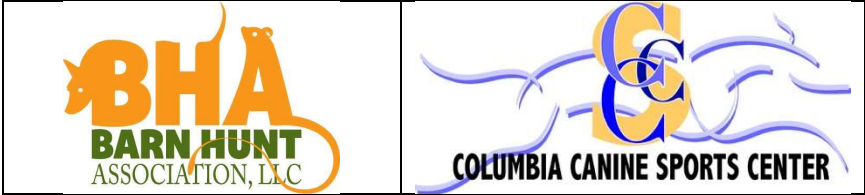

Check in at 7:30, General Briefing at 8:30 am with first dog to follow

There will be a short lunch break at the judges' discretion. Move ups will be allowed between trials. Remember if your dog has passed the Novice title you cannot enter Instinct.

Entries will be accepted on a first received basis, **opening March 26, 2025 at 8:00 am**, with early closing on **May 14, 2025 at 5:00 pm**. If limits are not reached by the closing, we will accept Late and Day of Show entries 1 hour before the

start time of each trial. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly. Any Judge of Record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the Course. Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

Entry fees are \$15 for Instinct, \$20 for Novice/Open, and \$25 Senior/Master/Crazy 8 classes. Late and Day of Show Entries are \$20 for Instinct, \$25 for Novice/Open, and \$30 Senior/Master/Crazy 8 classes.

EXHIBITOR INFORMATION

Site Information: The Barn Hunt site includes paved parking lots, the large training building, the Barn Hunt Shed, the Inside Ring, and the small building.

The Inside Ring is made of PVC pipe and vinyl lattice with a tarp on top of a rolled rubber flooring. The Barn Hunt Shed is a three-walled metal shed with lattice walls at the front. There are two doors into the shed. There are two support poles, and the floor is rolled rubber.

Blinds will be inside the Training Building. Instinct, Novice, Open, Senior and Crazy 8s will have blinds of 5 handler/dog teams. Masters will have blinds of 4 teams.

The Training Building, Small Building, and the Barn Hunt shed are handicap accessible. There are three handicap spaces on the West side of the Training Building.

Entry Information: You can enter online at <https://secreterrier.com/> (recommended method), or generate an entry form to mail in at www.barnhunt.org (second recommended method), or print out one of the attached entry forms. If you print and fill out an entry form, PLEASE WRITE CLEARLY! Illegible forms will not be processed!

Dogs may enter both the Instinct and Novice classes in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct class. Dogs completing the RATN in the morning trial either day may be moved up to Open for the next trial. This is up to the handler and not required. Move-ups will be accepted up until 1 hour before Trial 1 of each day. Move-up forms will be available at the Secretary's table.

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. **Make check payable to CCSC.** Send entries & fees to the trial secretary. Dogs must have a Barn Hunt registration number. Refunds will be made in full if a dog is pulled before the May 14, 2025, pre-entry closing date but not after except for a veterinary excuse with documentation.

Directions to the Trial Site: From East or West: take I-70 to Exit 261 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.

From North or South: take highway 63 to the I-70 interchange. Merge onto I-70 East and drive to Exit 261 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED IN THE BLINDS OR RINGS.** There is **NO SMOKING** in this facility or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also (this is a City Ordinance). Please pick up after your dog and dispose of waste in appropriate containers outside the building.

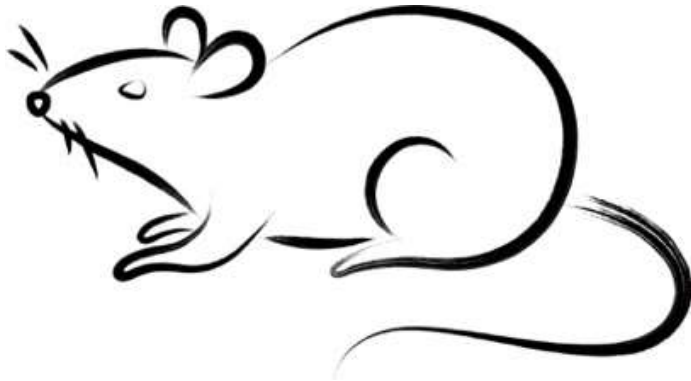
Awards: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. Rosettes will be awarded for first through fourth place in Novice through Master. High in Class ribbons and New Title ribbons will be awarded. Junior Qualifier ribbons are available.

Please bring weather appropriate gear. These trials will be a combination of indoors/outdoors depending upon the conditions. There will be indoor crating space available but please make sure your crate is secure as the dogs may be highly excited. Please use a mat underneath your crate.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties. Entry fees for bitches that come into season will be refunded until closing time of the

trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Please bring adequate water for you and your dogs. Lunch will be provided for volunteers. There are numerous fast-food restaurants within 5-10 minutes of the trial. There are indoor restrooms at the site.
